ENGLISH NAGAN RAYA (NBI) PROGRAM
Number: 25/KS-STIAPEN/II/2022**

On this day Tuesday the Fifteenth of February of the year Two Thousand Twenty-Two (15-02-2022) took place in Nagan Raya, the undersigned:

1. **Maulidar, S.E.,M.Si** as the Head of the Pelita Nusantara College of Administrative Sciences based on Decree number: 05/KEP/STIAPEN/IV/2023 dated April 25, 2023, addressed Jl. Simpang Peut - Jeuram, Cot Kuta Village, Suka Makmue District, Nagan Raya Regency 23671 in this case acting for and on behalf of the Pelita Nusantara College of Administrative Sciences, hereinafter referred to as **the FIRST PARTY**.
2. **Assoc. Prof. Ilham Sentosa as Director** of Training in Kuala Lumpur, 1016, Jln Sultan Ismail, Bandar Wawasan, 50250 Kuala Lumpur, Wilayah Persekutuan Kuala Lumpur, Malaysia which is further called **the SECOND PARTY**.

The FIRST PARTY and **the SECOND PARTY**, hereinafter collectively referred to as **the PARTIES** first explain the following:

1. That **the FIRST PARTY** is a Private University whose existence is intended to organize higher education and is engaged in education, research, and community service.
2. That **the SECOND PARTY** is the Director Of Training Lembaga Trainer&Reseach Malaysia

Based on the foregoing, the **PARTIES** agreed to resume the English Language Training cooperation in 2016 under the name of the English Language Nagan Raya Program (NBI) by signing a memorandum of understanding together:

**ARTICLE 1
LEGAL BASIS**

1. Law Number 20 of 2003 concerning the National Education System

- (State Gazette of the Republic of Indonesia of 2003 Number 78, Supplement to the State Gazette of the Republic of Indonesia Number 4301).
2. Law Number 12 Tahun 2012 concerning Higher Education (State Gazette of the Republic of Indonesia of 2012 Number 158, Supplement to the State Gazette of the Republic of Indonesia Number 5336).
 3. Government Regulation Number 4 of 2014 concerning the Implementation of Higher Education and Management of Higher Education (State Gazette of the Republic of Indonesia of 2014 Number 16, Supplement to the State Gazette of the Republic of Indonesia Number 5500).
 4. Regulation of the Minister of Education and Culture Number 14 of 2014 concerning Higher Education Cooperation.
 5. Regulation of the Minister of Technology Research and Higher Education Number 62 of 2016 concerning the Higher Education Quality Assurance System.
 6. Regulation of the Minister of Education and Culture Number 3 of 2020 concerning National Standards for Higher Education (Kampus Merdeka).

ARTICLE 2 AIMS AND OBJECTIVES

- (1) This Note of Understanding is the foundation for the implementation of cooperation in accordance with the scope agreed by **THE PARTIES**.
- (2) The purpose of this Memorandum of Understanding is to create synergy for the smooth implementation of the duties and obligations of the **PARTIES**.

ARTICLE 3 SCOPE

The scope of this Memorandum of Understanding includes synergy and cooperation in the following areas:

- (a). Education;
- (b) Research
- (c). **English Language Training**
- (d). Other areas agreed in accordance with the authority of the **PARTIES**.

ARTICLE 4 IMPLEMENTATION

Matters concerning the follow-up of this Memorandum of Understanding will be regulated and set forth in the cooperation agreement agreed by **the PARTIES** and are an integral part of this Memorandum of Understanding, in the form of: *Memorandum of Agreement (MOA)* and *Implementation of Agreement (IA)*.

ARTICLE 5 FINANCING

All costs incurred as a result of the implementation of this Memorandum of Understanding will be regulated in the Cooperation Agreement determined and agreed upon by **the PARTIES** in accordance with the provisions of laws and regulations.

ARTICLE 6 PERIOD

This Memorandum of Understanding is valid for a period of 3 (three) years from the moment it is signed and can be extended or terminated upon agreement of the **PARTIES**.

ARTICLE 7 CORRESPONDENCE

Any notice or communication of the **PARTIES** may be given in the form of a written letter and deemed received if sent in person or by registered mail and accompanied by its mark of faith or facsimile or electronic mail to the following address:

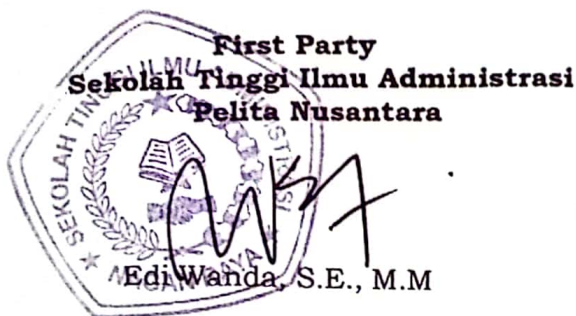
